- Review customers' requirements and contract specifications in order to deliver a service that meets and exceeds the customers' needs and expectations.
- Evaluate and select suppliers of goods and services based on their ability to assist us in achieving our objectives set out in this HSQE and EnMS policy.
- Minimize waste generation, preventing of pollution by promoting a culture of 'Reuse, Reduce, Recycle' and through the identification and sourcing of alternative materials and processes.
- Decrease of non-renewable energy consumption by supporting the procurement of energy efficient products and services that impact energy performances.
- Support design activities that consider energy performance improvements.
- Provide materials, plant and equipment to ensure compliance with our Health, Safety, Quality ,Environmental and EnMS Policy and procedures.
- Continuous development and improvement of our Integrated Management System to enhance HSQE and Energy performance through constant performance and evaluation.
